#### Treasurer

Board input on CD's they have come due in November. Bank of Springfield has interest rate at 4%—Do we want to put in the b.o.s. or leave them where they are at? Board suggested to move monies to checking at b.o.s. because of the interest rate being at and will be insured to the fullest extent.

Mark McGrath says that the treasurer can move monies as long as you have collateral insurance to cover the funds, and as long as the board has already approved the bank. Audit is still in progress bill for \$42,000 Risk management is due on 11-11-2025 pay them in full and get a discount of 1%.
