Discussion Items:

Henry Dawdy questioned the square footage that was written up and that was changed to 2 square feet per hen and 10 feet from property line along with 50ft of a neighbor's dwelling. Sent changes to Daniel Biehl to go over and send to the attorney then approve the final changes on 12 November 2025 Ordinance meeting.

Vote on ordinance chapter number 76 to remove motor vehicle ordinance because that is what the state has already for speed limits.

Motion to remove Chapter 76 Motor Vehicle offenses out of the ordinances first by Lonnie Kirby, and second by Pam Page All approved 3-0

Henry Dawdy—Yard Junk and Debris/ Nuisance

Discussion: All residential and commercial properties for every property in the Village of McLean to be the same across the board. Simplify it so that everyone in the public can understand the ordinance.

Lonnie Kirby wants the main concern to be safety and sanitation.

2nd offense is a fine notice to abate verbal

3rd offense is to move forward with fines up to \$500.00 depending on severity on what to charge each individual person.
