Motion by West 2nd Hammel to approve minutes of the October 2, 2017 regular board meeting. All ayes, motion carried.

Motion by Hammel 2nd West to accept bills as presented. ROLL CALL-Hendrickson, Shifflet, Billington, Hammel and West. All ayes, motion carried.

EASEMENT AGREEMENT ON ROBERTS PROPERTY-McGrath reported he received this this afternoon. Part of it is not in Village and will need to annex. He stated the board needs to approve this and have Hammel make any changes if needed. Deadline would be effective date of last party signing. Motion by West 2nd Hendrickson to accept easement with Hammel and McGrath to approve any changes. ROLL CALL-Shifflet, Billington, West, Hammel and Hendrickson. All ayes, motion carried.

GRANT REQUEST FROM OLY SOUTH BASKETBALL-Dennis Rich is asking for a \$1000.00 grant for the above. Motion by Hendrickson 2nd Billington to approve grant and pay \$200.00 out of Wheelock & Aldrich Fund and \$800.00 out of General Fund. ROLL CALL-Hendrickson, Shifflet, Billington, West and Hammel. All ayes, motion carried.

Motion by West 2nd Hendrickson to approve option #1 for the IMLRMA Insurance renewal. ROLL CALL-Shifflet, Billington, West, Hammel and Hendrickson. All ayes, motion carried. McGrath stated that Bliss/McKnight may be more economical than IMLRMA and maybe should look into this in the spring.

UPDATED VILLAGE CODE BOOK-we cannot update the Copy of the written Code or copy it. The cost could be \$850.00 with binder plus shipping. Suggested to just have the one in the office to use. McGrath will check on copyrights and come back with a budget and Village Code update next month.

DANGEROUS BUILDING-113 W. Charles St.-there will be a hearing on Nov. 20, 2017. Deborah Furman and Mid-Tax have been served. The procedure will be to declare the property abandoned and dangerous. This will speed up the process. The Village is liable for cost and then the Village will own the property. Motion by Hammel 2nd Hendrickson to authorize McGrath to file a petition to have this declared abandoned and dangerous. ROLL CALL-Billington, West, Hammel, Hendrickson and Shifflet. All ayes, motion carried.

HOTEL/MOTEL TAX FOR THE ARCADIA UPDATE-Williams sent a letter to John Yates. He sent \$630.00 to the Village but he needs to send a monthly report to the Village. If he does not comply with this then McGrath will send a letter to him. Keep this on the agenda.
