# ORDINANCE NO. 13-08-05

AN ORDINANCE AMENDING THE VILLAGE OF MCLEAN MUNICIPAL CODE SAID MUNICIPAL CODE BEING ORDINANCE NO. 96-5-6A OF THE VILLAGE OF MCLEAN TO PROVIDE AMENDMENTS RELATING TO UTILITY RATES AND CHARGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MCLEAN:

SECTION 1: §171.02(A)(1)(b) of the Village Code of the Village of McLean is hereby changed by deleting the provisions of that sub-section and inserting the following:

§171.02(A)(1)(b) Water Re: Connection after shutoff. \$50.00, plus the unpaid balance and any unpaid meter use fee for the service site as provided for in \$171.02(C).

SECTION 2: §171.02 of the Village Code of the Village of McLean is hereby amended by deleting sub-paragraph (C) Late Penalties and inserting in place thereof the following sub-section:

§171.02(C) Meter Use Fee.

(1) In addition to the water and sewer charges each site that has a water meter shall pay a fee of \$11.76 per month per live meter access point for each month that it is located at a service site even if water and sewer service is not active at the site. A live meter access point is defined as "each meter yolk with or without a meter installed, that is served by a live water tap." This is a facilities charge to provide payment for the water tower and is not subject to the rate increase provided for in \$171.02 (B)(3). The monthly meter fee shall be added to the water and sewer bill that is issued to each customer and shall be due and payable when the water and sewer bill is required to be paid. In the event that a service site is not receiving water and sewer service then the meter use fee shall be due and payable when the water and sewer bill is required to be paid. Failure to pay the meter use fee shall be subject to the late penalty provisions of §171.02(D) hereinafter provided.

SECTION 3: A new §171.02(D) Late Penalties, is hereby added to the Village Code of the Village of McLean which is as follows:

(1) §171.02(D) Late Penalties: A ten percent (10%) late penalty shall be charged and added to each bill that has not been paid by the due date. Payment shall be considered "paid" when received by the Village. Partial payments or payments by checks that are not honored shall not be considered "paid" until paid in full by cash, money order, or until such time as the dishonored check is honored. In the event that an account is more than thirty (30) days past due and service has not been disconnected an additional ten percent (10%) shall be added to the customer's bill for each and every month that the bill remains unpaid after the scheduled due date provided that in no event shall the late penalties provided herein exceed \$500.00 per month.

(2) Penalties shall be compounded and thus penalties shall be calculated on top of penalties.

SECTION 4: §51.05 of the Village Code of the Village of McLean is amended by interlineation by adding after the word "water" wherever the word appears within §51.05, "sewer and meter use fee".

SECTION 5: §51.05 of the Village Code of the Village of McLean is amended to delete the word "Clerk" wherever that word appears and to substitute in place thereof the word "Treasurer".

SECTION 6: If any section or part of this Ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.

SECTION 7: This Ordinance shall take effect 10 days after publication thereof as provided by law.

SECTION 8: Ordinance No.96-5-6A of the Village of McLean, as amended by this Ordinance, shall remain in full force and effect and all previous amendments to Ordinance No. 96-5-6A shall remain in force and effect except as modified by this Ordinance.
