ORDINANCE NO. 15-01-05

AN ORDINANCE AMENDING THE VILLAGE OF MCLEAN MUNICIPAL CODE SAID MUNICIPAL CODE BEING ORDINANCE NO. 96-5-6A OF THE VILLAGE OF MCLEAN TO PROVIDE AMENDMENTS RELATING TO CRUELTY TO ANIMALS

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MCLEAN:

SECTION 1: §91.14 is hereby added to the Village of Code of the Village of McLean which is as follows:

SECTION 91.14 CRUELTY TO ANIMALS PROHIBITED.

- (A) No person or owner may beat, cruelly treat, torment, starve, overwork, cruelly or maliciously shoot, poison, kill, ill-treat, torture, mutilate or otherwise abuse any animal within the Village of McLean.
- (B) It shall be unlawful for any person to fail to provide any animal in one's charge or custody, as owner or keeper, with proper food, drink, shelter, air, sanitation, or medical care.
- (C) No owner may abandon any animal where it may become a public charge or may suffer injury, hunger, or exposure.

SECTION 2: If any section or part of this Ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.

SECTION 3: This Ordinance shall take effect 10 days after publication thereof as provided by law.

SECTION 4: Ordinance No.96-5-6A of the Village of McLean, as amended by this Ordinance, shall remain in full force and effect and all previous amendments to Ordinance No. 96-5-6A shall remain in force and effect except as modified by this Ordinance.
