BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MCLEAN, MCLEAN COUNTY, ILLINOIS:

SECTION 1:

Ordinance No. 16-07-11, which was an ordinance appropriating the sums of money necessary to defray all expenses and liabilities of the Village of McLean, McLean County, Illinois for the fiscal year of May 1, 2016 through and including April 30, 2017 is hereby amending by deleting **SECTION 5** and substituting in place thereof the following **SECTION 5**:

SECTION 5: Section 11-74.4-55(j) of the Tax Increment Allocation Redevelopment Act requires the Village to include in its annual budget certain information regarding the Village's tax increment finance district for the proceeding fiscal year. Specifically, the Village is required to set forth in its annual budget the revenues generated from redevelopment project areas by source and the expenditures made by the Village for redevelopment project areas. The following information is hereby furnished:

TIF Income and Expenditures for Prior Fiscal Year (May 1, 2015 through April 30, 2016)

**A. TIF Income by Source for Prior Fiscal Year:**

SECTION 2: Except as modified by this Ordinance, Ordinance No. 16-07-11 of the Village of McLean shall remain in full force and effect.


SECTION 3: If any section, subdivision or sentence of this ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.

SECTION 4: A certified copy of this Supplemental Budget and Appropriation Ordinance shall be filed with the County Clerk of McLean County by the Village Clerk within 30 days after the adoption of this Ordinance.

SECTION 5: This Ordinance shall be in full force and effect from and after its passage and approval according to law.


