ORDINANCE NO. 18-11-05

AN ORDINANCE REPEALING ORDINANCE NO. 18-07-02 WHICH WAS AN
ORDINANCE RELATING TO HOTEL AND MOTEL TAX

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE
OF MCLEAN AS FOLLOWS:

WHEREAS, on July 2, 2018, the Village of McLean adopted Ordinance 18-07-02, which
related to amendments to the Village Code relating to hotel and motel tax; and

WHEREAS, inadvertently on October 1, 2018 the Board of Trustees of the Village of
McLean adopted Ordinance 18-10-01(A) to provide amendments to the Village Code relating to
hotel and motel tax; and

WHEREAS, Ordinance 18-10-01(A) was inadvertently adopted by the Village of
McLean and is identical in its terms and conditions to Ordinance 18-07-02.

NOW, THEREFORE, be it ordained by the President and Board of Trustees of the
Village of McLean

SECTION 1: Ordinance 18-10-01(A) is repealed in its entirety

SECTION 2: Ordinance 18-07-02 is not affected by this ordinance and is not repealed


SECTION 3: If any section or part of this Ordinance is held invalid, it shall not affect
the validity of the remainder of this Ordinance.

SECTION 4: This Ordinance shall take effect 10 days after publication thereof as
provided by law.

SECTION 5: Ordinance No. 96-5-6A of the Village of McLean, as amended by this
Ordinance, shall remain in full force and effect and all previous amendments to Ordinance No.
96-5-6A shall remain in force and effect except as modified by this Ordinance.
