ORDINANCE NO. 31-03-01

AN ORDINANCE AMENDING THE VILLAGE OF MCLEAN MUNICIPAL CODE, SAID MUNICIPAL CODE BEING ORDINANCE NO. 96-5-6A OF THE VILLAGE OF MCLEAN, TO PROVIDE AMENDMENTS RELATING TO PENALTIES FOR STORAGE OF VEHICLES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MCLEAN:

SECTION 1: Chapter 140 of the Village of Code of the Village of McLean is hereby amended by adding a new §140.07, which is as follows:

§140.07: Penalty. Whoever violates any provisions of this chapter shall be subject to the general penalty provisions of §10.99 of the Village Code. Each day that a violation continues shall be deemed a separate offense.

SECTION 2: If any section or part of this Ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.

SECTION 3: This Ordinance shall take effect 10 days after publication thereof as provided by law.

SECTION 4: Ordinance No.96-5-6A of the Village of McLean, as amended by this Ordinance, shall remain in full force and effect and all previous amendments to Ordinance No. 96-5-6A shall remain in force and effect except as modified by this Ordinance.
